PUBLIC HEARING – Local Law #7 Mayor read:

PLEASE TAKE NOTICE that the Village Board of the Village of Harriman will hold a public hearing on a proposed local law rezoning the property identified as Town of Woodbury tax map parcel 108-1-10, also known as Lot B-12, ICC Site B, on Commerce Drive in the Village of Harriman consisting of approximately 7.8 +/- acres, and amending the official Village zoning map to reflect this amendment.

Approximately two thirds of the subject property is currently located in the I-Industrial Zoning District and the remaining one third is currently located in the PAD-Planned Area Development Zoning District rendering development of the parcel difficult and impractical. The Amendment will designate the entire parcel within the I-Industrial District to allow for development of the property that is consistent with the surrounding area and development pattern as it currently exists on Commerce Drive.

The hearing will be held at the Village at Harriman Village Hall, 12 Church Street, Harriman, New York on December 14, 2021at 7:25 p.m. or as soon thereafter as the matter may be heard. A copy of the local law will be available for inspection at the office of the Village Clerk, 12 Church St., Harriman, NY.

All persons interested in the subject of the proposed local law will be heard by the Village Board at the above time and place. Persons may appear in person or by agent. All written communications addressed to the Board in connection with the proposed local law must be received by the Village Board at or prior to the public hearing.

Mayor asked have we had any written comments?

Clerk replied no.

Mayor stated having no written comments I open it up to the public for any comment on this matter.

Charlie Bazydlo, Counsel for the owner of the property, stated obviously we are in favor of this local law. I appreciate the Boards efforts on getting this together and if the Board passes this local law it will make the development of the property more consistent.

PUBLIC HEARING – Local Law #8:

Mayor read:

Please take notice that the Village Board of the Village of Harriman will hold a public hearing to receive public comment on a proposed local law, pursuant to Article 6, § 131 of the N.Y.S. Cannabis Law, opting out of allowing retail cannabis dispensaries and on-site cannabis consumption establishments in the Village of Harriman.

The effect of the local law would be to prohibit the establishment of retail cannabis dispensaries and on-site cannabis consumption establishments within Village limits. The local law is subject to a permissive referendum pursuant to Municipal Home Rule Law § 24 and Village Law § 9-902.

This public hearing will be held at Harriman Village Hall, 12 Church Street, Harriman, New York on December 14, 2021 at 7:25 pm or as soon thereafter as the matter may be heard.

A copy of the proposed local law is available for inspection at the office of the Village Clerk, 12 Church St., Harriman, NY., or by requesting a copy from the Village Clerk at 845-783-4421, or villageclerk@villageofharriman.org.

All persons interested in the subject will be heard by the Village Board at the above time and place. Persons may appear in person or by agent. All written communications addressed to the Board in connection with the proposed Plan must be received by the Village Board at or prior to the public hearing.

Andrew Chagaras – Candlewood – I am not a user, but I think that we shouldn't opt out. I feel like it would be good for taxes. I know that the Village of Woodbury is allowing it. Tuxedo is allowing it. I feel like for taxes reasons it would be a great thing possibly for the community. I don't really see that much harm in it. I am not an expert, but it is just how I feel. I feel it might be good for taxes or revenue, but you guys probably know much more about this then I do.

Jim Kelly – Oxford Lane - we live in a very small Village and he said taxes, will save on taxes. That is really not going to happen because once you start to involve other issues like these kinds of shops you have to increase your police and that is a large burden to this small Village as you all know. We don't even have a bar in Harriman. The people that are coming up and that I can see that are moving in are young families with children and I can see places that would want this. I can see larger Village's, but how many people live in this Village and we need a cannabis store and there is not even a bar in this Village. It is just a quaint little Village and if you ask the majority of the people, and I know you are thinking the taxes and that is not a bad thing. It would change the whole environment. I was kidding before about the Photo News. There is more DWI's that are policeman stop in this Village then you can believe. This is a small Village and I just don't see having something like that in a small Village like this. People are just buying their house and we have a lot of new people moving in with little children and I don't think that is the atmosphere they would really want to see over in Harriman. You mentioned Woodbury and Tuxedo. I don't know about Monroe or what they are going to do, but I think it is a bad idea. I think we should get out of it and not really be a part of it, just for the sake of the people living in the little Village. If they want to go let them go to Tuxedo or Woodbury, if that is what they want. If you want to go shopping, you have to go to Woodbury. Why do we have to have it here?

I just want to say, to the point of taxes, do you understand the way the Municipality receives taxes from this is only on what is sold or distributed or dispensed within the one-mile area of the Village of Harriman and we would also be splitting that small amount with the County and State. While it seems like it might be a boondogle for taxes. It really is only what is sold within the Village of Harriman should we not opt out.

BUDGET ADJUSTMENTS AND TRANSFERS

Mayor stated the Board has received a request from the Treasurer for Budget Adjustments and Transfers. The Budget Adjustment is for transfer of funds received, which is the 8th Capital Contribution funds from the Shops of Woodbury of \$100,000.00 and the Budget Transfer is due to a Police Server Failure that occurred within the last couple of weeks. There was an emergency need for upgrading operating systems and application software to current levels. That is \$4,000.00 that budget transfer and due to new Officers coming on and additional uniforms needed to be purchased she will need to make a transfer of \$2,000.00.

ATTORNEY COMMENT –

Attorney Darwin stated in regards to 4 South Main Street we had two more conferences with the referee since the last Board Meeting. One on December 2^{nd} – the second lien holder was saying they still haven't received all the documents that they needed although they all had been sent. I mentioned during that conference that this Board was beyond impatient with the process and I also mentioned that there had been some discussion about the possibility of the Board adopting a Resolution to cancel the Contract and proceed with other options.

The referee then scheduled a second conference for today. Today's conference we were informed that the second lien holder, the second lien holder is the problem not the first lien holder. The first lien holder approved the short sale and accepted the Village's amended offer. They have all the documentation now. It had a preliminary review. It has to go up the ladder for a final review. The first lien holder has extended the deadline within which this has to be concluded to January 10, 2022. Which is the day before the next Village Board Meeting. So, it appears as though, the closing would occur by the 10th. At least it appears as though there is a good possibility we will be closing on or before January 10, 2022. If there is no closing by January 10, 2022 the first lien holder has indicated that it is not going to extend that deadline any further. In which case the short sale approval would be null and voided and then the Village Board would proceed with the other options that it has to require the property. At least we know some progress has been made and everybody involved appears to believe we will be closing by January 10, 2022.

Trustee Daly replied thank you Dave it has been a long ride.

Mayor stated so it is January 10th or nothing at that point and we have our next Board Meeting the next night so we can let them know we are done at that point. The first lien holder is basically saying they are done too, and we would be done.

PUBLIC COMMENT –

Andrew Chagaras – I was wondering if it is possible – I know for drinking water they passed the Clean Water Act, can we jump in on that? I keep getting notices every once in a while and I read it as don't drink the water or drink at your own risk. I have one home that I live at with my family and I had an investment property, but I sold it last year because I didn't want to run in a predicament with someone not paying me, but the investment property was Lexington Hills and I would still get the same notices, don't drink the water.

Mayor stated we never issued a don't drink the water.

Mr. Chagaras well no, it says certain parts per million of uranium that are above the legal limit. I don't know if we can qualify if they are fixing things, it would be great to not get those notices.

Mayor replied it would be great for us not to have to send them.

Mr. Chagaras if it is possible that would be great. I am all for it, plus I also have my own Plumbing, Heating, Cooling Company and I bid State work so I would love to do the work as well.

Mayor responded what we actually did last month is we just authorized grant money that we are pursuing three separate grants to help mitigate the situations that we are dealing with here in the Village with having to dilute to get the levels at the right level or to expand old Booster Stations. So just last month the Board approved and the grant applications are already in place for doing things that can help mitigate the situation because we have to be proactive too.

Mr. Chagaras replied that's great, nice and of course.

Mayor stated and those are all funded under the Clean Water Act. Federal Funds are available to us. We are trying to pursue as many as we can and have three so far.

Bruce Abrignani – 87 Route 17M – I have an ongoing problem for years as far as the water coming down from behind my property and over the years with the rainstorms it is getting worse and worse. The inside of my building has taken on water and I just need some guidance. Is it the Town of Monroe's problem or a State problem or the Village of Harriman problem? I am coming here first to try and get some direction because as development of Harriman Heights Road gets worse, I'm sure my building will incur more damage. So, I am trying to get some direction.

Mayor stated Kyle I'm sure you discussed this with Bruce Abrignani?

Kyle replied yes.

Mr. Abrignani replied several weeks ago.

Mayor asked did that help to figure out where you need to be?

Mr. Abrignani replied it is a starting point, but I think we need a conference between people who know what is going on between the County or State.

Mayor asked is a portion of it privately owned right behind you?

Mr. Abrignani replied behind me is private property, but it comes on their property from up the street. So, I mean water comes down the hill where the source is. It comes from culverts; private property and it comes down hill.

Mayor stated Kyle and I will talk more about it as well.

Mr. Abrignani replied thank you.

MOTION was made by Trustee Chichester to enter into Executive Session for Attorney Client Privilege to discuss an HR issue.
