PLEASE TAKE NOTICE THAT the Village Board of the Village of Harriman will hold a public hearing on proposed Local Law No. 6 of 2022 entitled "A Local Law to Repeal Local Law Number 2 of 2022" at 12 Church Street, Harriman, New York (formerly the Harriman School) on June 14, 2022 at 7:20pm or soon thereafter as the matter may be heard. Said currently proposed Local Law will allow the Village of Harriman to repeal Local Law No.2 of 2022, which was adopted on February 8, 2022 which granted authority to the Village Board to override the limit on the amount of the real property taxes that may be levied, pursuant to the General Municipal Law §3-C and which would have allowed the Village Board at its discretion to adopt a Village budget for fiscal 2022/2023 that require a real property tax in excess of the tax levy.

PLEASE TAKE FURTHER NOTICE that the Village Board adopted a Village budget for fiscal 2022/2023 that did <u>not</u> exceed the tax levy limit, and therefore, the Village Board wants to repeal Local Law No.2 of 2022, thereby, making the Village residents eligible for a New York State Property Tax Rebate Program.

All persons interested in the subject of the proposed local law will be heard by the Village Board at the above time and place. Persons may appear in person or by agent. All written communications addressed to the Board in connection with the proposed local law must be received by the Village Board at or prior to the public hearing.

PLEASE TAKE NOTICE that the Village Board of the Village of Harriman will hold a public hearing on a proposed local law introductory #7 of 2022 amending and revising Chapters 74 and 78 of the Code of the Village of Harriman pursuant to Sections 10 and 20 of the Municipal Home Rule Law at the Harriman Village Hall at 12 Church Street, Harriman, New York on June 14, 2022 at 7:20 p.m. or as soon thereafter as the matter may be heard.

The purpose of this local law is to amend and update sections of the Village Code by increasing certain fees and eliminating, consolidating and renumbering certain sections of Chapters 74 and 78. The affected sections include: Chapter 74 – Fees: § 74-5A (1) (f) (installation or removal of fuel tanks) and (g) (heating equipment replacement; § 74-5A (16) (b) (residential rental registration) and 74-5A (16) (c) (1), (2), (3), (4) and (5) (fire safety inspections). This local law will also update and amend §§ 78-16 D (3) 78-16 F (4) relating to certain residential rental unit fees

A copy of the proposed local law will be available for inspection at the Village Clerk's office located at 12 Church St., Harriman, NY.

SEOR RESOLUTION FOR \$100,000 SAM GRANT FOR PAVING PROJECT

Mayor read:

RESOLUTION DETERMINING THAT THE REPAVING OF FOUR VILLAGE ROADS IS A TYPE II ACTION UNDER THE STATE ENVIONRMENTAL QUALITY REVIEW ACT AND ACCEPTING A GRANT FROM DASNY UNDER ITS "SAM" PROGRAM FOR THE REPAVING PROJECT

WHEREAS, the Village of Harriman proposes to mill and repave the following Village roads: Dover Road, Oxford Lane, Kensington Way and Scarborough Place ("the Project"); and

WHEREAS, the Dormitory Authority of the State of New York ("DASNY") has awarded the Village a grant in the amount of \$100,000.00 for the Project under its State and Municipal Facilities Program ("SAM") Project ID: 24967; and

WHEREAS, the Village Board of the Village of Harriman desires to accept the grant award for the Project; and

WHEREAS, pursuant to the § 617.6 of the regulations issued under the State Environmental Quality Review Act ("SEQRA") the Village is required to make an initial determination whether the Project is subject to SEQRA; and

WHEREAS, under § 617.5 (c) (5) repaving of roads not involving the addition of new travel lanes is a Type II action not subject to review under SEQRA, and under § 617.5 (c)(2) the replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site is as Type II action unless such action meets or exceeds any of the thresholds in section 617.4 of this Part; and

WHEREAS, the project involves the physical alteration of 3.3 acres and does not include additional travel lanes, and the Village has obtained an opinion from the New York State Office of Parks, Recreation and Historic Preservation (OPRHP) that no properties, including archaeological and/or historic resources, listed in or eligible for the New York State and National Registers of Historic Places will be impacted by this Project, and the Project does not meet or exceed any of the thresholds in § 617.4; now, therefore, it is hereby

RESOLVED, that the Village Board of the Village of Harriman determines that the Project is a Type II action under SEQRA, that it is not subject to review under SEQRA and its regulations and that no further action under SEQRA is required; and it is further

RESOLVED, that the Village Board accepts the grant award in the amount of \$100,000.00 for the Project from DASNY under its SAM Program Project ID 24967 and that the Mayor is hereby authorized to execute and submit any and all grant contract documents in connection therewith.
