PLEASE TAKE NOTICE that the Village Board of Trustees of the Village of Harriman will hold a public hearing on Local Law Introductory # 2 of 2024, Chapter 132, Article VI, 132-42 Schedule VIII, at the Village of Harriman Village Hall, 12 Church Street, Harriman, New York on March 12, 2024 at 7:20 p.m. or as soon thereafter as the matter may be heard.

The purpose of the Local Law is to add to the list of stop intersections Melody Lane in the Northeasterly direction of travel at its intersection with Brookside Drive West located in the Village of Harriman. The previously published public hearing notice incorrectly designated the location of the stop sign as Melody Lane in the Westerly direction of travel at its intersection with Brookside Drive West.

PLEASE TAKE NOTICE that the Village Board of Trustees of the Village of Harriman will hold a public hearing on Local Law Introductory # 3 of 2024, amending Chapter 118, Article IV – Tax Exemption for Volunteer Emergency Personnel, at the Village of Harriman Village Hall, 12 Church Street, Harriman, New York on March 12, 2024 at 7:25 p.m. or as soon thereafter as the matter may be heard.

The purpose of the local law is to implement the authority granted to local taxing jurisdictions by NY Real Property Tax Law Section 466-a, authorizing municipalities to adopt a local law which will provide enrolled volunteer firefighters and voluntary ambulance workers with an opportunity to be eligible for a new real property tax of up to ten percent of the assessed value of the primary residence of such qualifying volunteer firefighters and ambulance workers, and provide a continuation or reinstatement of a real property tax

exemption of ten percent of the assessed value of the primary residence for surviving spouses, who have not remarried, of formerly enrolled volunteer firefighters and voluntary ambulance workers to the extent authorized by Section 466-a.
