PLEASE TAKE NOTICE that the Village Board of the Village of Harriman will hold a public hearing on a proposed local law # 9 of 2020 entitled Amendment to Local Law No. 6 of 2020 establishing a "Benefit Assessment Area for Stormwater/Drainage Improvements" pursuant to Sections 10 and 20 of the Municipal Home Rule Law, on August 8, 2020 at 7:20 p.m. or as soon thereafter as the matter may be heard.

The purpose of this local law is to correct a clerical error in Local Law No. 6 of 2020, which incorrectly identified the proposed assessment area as tax map no. 101-1-1.3. The correct tax map number is 101-1-1.31. In all other respects Local Law No. 6 will remain unchanged.

A copy of the proposed local law and a copy of the map, plan and report describing the proposed benefit assessment area with the correct tax map reference will be available for inspection at the office of the Village Clerk, 12 Church St., Harriman, New York.

All persons interested in the subject of the proposed local law will be heard by the Village Board as set forth above.

- 2 Maple Avenue – the hold-up on the remaining material that is there, which is mainly block cement/stone. They were waiting for the testing to come back to verify whether of not it contained any asbestos. The testing has come back, and it is negative for asbestos. Now they are waiting for the Department of Labor to sign off on it before they can go any further. Once they hear back from them, they will continue to remove the remaining debris and finish up the project. Mr. Coleman asked was there any mention of the trees?

Is there a way we can promote these things happening in the Village to get more people? Some of these stores are empty, maybe if we just said they are reopening, and I don't mean us. Could we contact the Chamber of Commerce?
